SCHOLARSHIP CANCELLATION POLICY for Greater Phoenix Chapter members for local, Region 8 and online courses:
 Full and partial Scholarships are available for the following courses offered by IREM[®] Greater Phoenix Chapter: RES201, FIN402, HRS402, MKL405, MKL406, MNT402, ASM603, ASM604, ASM605, MPSAXM and CPMEXM. Chapter scholarships may also apply for the online courses at 50%. Chapter scholarships may also take Region 8 courses applying a maximum of \$500 toward the course if it is not offered in Phoenix. The Chapter will review all out of state courses and determine the scholarship amount to be honored. **NOTE:** Ethics course is not included.

- To cancel your registration, notify IREM Headquarters at getinfo@irem.org or by mail.
- If your cancellation request is received within 10 or more business days prior to the start of the course – you may either transfer to another course or delivery format or receive a full refund of your registration fee.
 - If your cancellation request is received less than 10 business days but a minimum of 3 business days prior to the start of the course – you may either transfer to another course or delivery format or receive a refund of your registration fee less a \$75 administrative fee. The \$75 administrative fee is applied to each individual course cancelled. Transferring to another course or delivery format is only valid for up to 12 months from the date of cancellation.
 - If your cancellation request is received within 3 business days prior to the start of the course or you are a no-show – your registration fee cannot be refunded nor can you transfer your registration to another course.

IREM may from time to time find it necessary to cancel a course. In such cases, you may choose to transfer to another course or delivery format or your registration fee will be fully refunded. However, IREM assumes no liability for any expenses incurred other than the registration fee. You may forfeit your eligibility for future local chapter scholarships if the cancellation policy requirements are not fulfilled.
